7:00 AM	Depart Peoria Charter, 2600 NE Adams Street, Peoria (Waiting Room)
7:25 AM	Depart Morton from WalMart, 155 E Courtland Street, (Behind Culvers)
8:00 AM	Depart Normal from Schnuck's off Raab Road, 1750 Bradford Lane. We'll make a ½ hour break stop at McDonalds in LeRoy before picking up in Champaign/Urbana.
9:30 AM	Depart Urbana from Peoria Charter, 1910 N Federal Drive traveling south to our destination – Arthur, Illinois – Heart of Amish Country!
10:00 AM	Upon arrival in Arthur, we'll make a stop at the Visitor's Center where you can use the facilities after your long ride and visit downtown Arthur. We'll meet our Step-on Guide for a Driving Tour* through the Amish Countryside.

3:30 PM	It's time to depart for home.

6:15 PM	Approximate return time to Morton.
6:45 PM	Approximate return time to Peoria.
