



# PEORIA CHARTER TRAVEL

## Door County in the Fall

October 14 – 17, 2025  
4 Days / 3 Nights

### Day #1 – Tuesday, October 14<sup>th</sup>:

- 5:30 AM** Depart Peoria Charter from 2600 NE Adams Street
- 5:30 AM** Depart Urbana, 1910 N. Federal Drive on a shuttle van or bus to our Normal stop to meet the main coach.
- 5:55 AM** Depart Morton from Wal Mart, (behind Culvers), 155 E Courtland St
- 6:30 AM** Depart Normal from Schnuck's off Raab Road, 1750 Bradford Lane. The Shuttle from Urbana transfers passengers to the main coach before we travel northeast towards Milwaukee. We'll make a rest stop along the way.
- 11:30 AM** We arrive in Milwaukee at the **Milwaukee Public Market** where you'll enjoy lunch on your own.
- 12:30 PM** It's time to depart for Sturgeon Bay, Wisconsin. We'll make a rest stop along the way.
- 3:45 PM** Arriving in Sturgeon Bay we make a stop at **Door County Coffee Shop** where you can get your coffee fix for the afternoon.
- 4:15 PM** We're back aboard the coach traveling on to Egg Harbor where we'll overnight for the next 3 nights.
- 5:00 PM** Approximate arrival time in Fish Creek at the **Newport Resort\***. We'll check in and get ready to head out to dinner.
- 6:00 PM** **Dinner\*** tonight will be at Wild Tomato's Pizza. Enjoy several different pizza selections and drinks.
- 8:30 PM** Approximate return time to the hotel for the evening.



### Day #2 – Wednesday, October 15<sup>th</sup>:

- 7:30 AM** We depart for **Al Johnson's Swedish Restaurant for Breakfast\***. You'll enjoy Swedish Pancakes, Swedish Meatballs & Juice. Watch outside to see if the goats are grazing on the roof. (**8:00 AM Reservation**)

**11:30 AM** Our next stop is the **Cana Island Lighthouse for a tour\***. This is Door County's most iconic lighthouse, standing watch on the shores of Lake Michigan for over 150 years. Ride a hay-wagon over the causeway to explore the island, including the 89-foot-tall light tower, oil storage house and lighthouse keeper's home. Climb the 97 steps of the tower's spiral staircase to enjoy the sweeping panoramic view of Lake Michigan and the Door County Peninsula. **(11:30 – 1:30 PM)**



**1:30 PM** And finally, we depart for Lunch on your own and a little shopping in Fish Creek.

**3:30 PM** We head back to the hotel for a quick “Freshen Up” before heading out for dinner.

**4:15 PM** Let's board our coach and depart for **Alexander's Restaurant for Dinner\***. Alexander's is fine dining at it's best at this lovely restaurant. **(4:30 – 6:00 PM)**

**6:15 PM** We travel the short distance to **Northern Sky's Gould Theater for an evening performance of “The Bachelor's”\***. **(7:00 – 9:30 PM Showtime)**

**10:00 PM** Approximate return time to the hotel for the evening.

### **Day #3 – Thursday, October 16<sup>th</sup>:**

**7:15 AM** This morning we travel to **Pelletier's Restaurant for Breakfast\***.

**8:30 AM** Following breakfast, we travel to Sturgeon Bay to board the **Door County Trolley for an All Day trolley ride including Lunch\*** giving us the history and beauty of this area in the fall. **(9:00 – 3:30 PM Reservation)**

**3:30 PM** Following the trolley tour, we depart for **The Den Restaurant for a Fish Boil Dinner\***. Chicken will be offered if you don't like white fish. The boil over is at 5:00 PM followed by a seated dinner where you'll enjoy the white fish you just witnessed being cooked. **(4:30 PM arrival, 5:00 PM Boil Over, Dinner follows)**

**6:00 PM** We have an early night at the hotel tonight following the fish boil.



### **Day #4 – Friday, October 17<sup>th</sup>:**

**7:00 AM** **Breakfast\*** is included this morning at **Julie's Café**.

**8:15 AM** We depart for a stop at **Renard's Cheese\***. Here you'll be able to purchase your favorite cheese to take home with you.

**9:15 AM** Next, we depart for the **Door County Maritime Museum & Tower for a tour\***. The museum features interactive exhibits and offers a tour of the Jim Kress Maritime Lighthouse Tower. Hard-working anglers, brave ship captains, skilled craftsmen, bold inventors and lonely lighthouse keepers are just some of the personalities you'll discover in the galleries of the museum. See

how these maritime pioneers worked and what they made, and you'll understand and appreciate your visit to Door County on a deeper, more engaged level.

**(10:00 AM – Noon Reservation)**

<b>Noon</b>	Time will be given to grab lunch on your own and get in a little shopping in Sturgeon Bay before departing for home.
<b>2:00 PM</b>	It's time to depart for home making rest and meal stops along the way.
<b>9:00 PM</b>	Approximate arrival time back in Normal. Shuttle bus or van will be waiting to take the Urbana passengers home.
<b>9:45 PM</b>	Approximate arrival time back to Morton.
<b>10:00 PM</b>	Approximate arrival time back to Urbana.
<b>10:15 PM</b>	Approximate arrival time back to Peoria.
