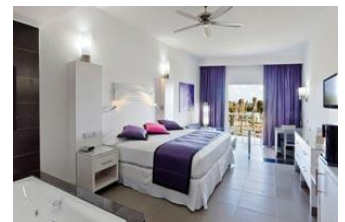
Proof of Citizenship: You will be required to present a valid passport at the time of airport check-in that is valid for 6 months after your return.
